Scope of Available Products & Services:

Technical Category 1 (TC1)

- **Infrastructure** - includes software, communications infrastructure, microwave, control/base stations, repeaters, comparators, encryption equipment, and test equipment
- **Radios & Accessories** - includes end-user equipment and all associated accessories
- **High Frequency** - includes end-user equipment, associated accessories, and infrastructure to support
- **Maritime** - includes tactical communication equipment to outfit and interface with boat crew communication system
- **Satellite** - includes end user equipment, associated accessories, and dishes

Technical Category 2 (TC2)

- **Radio** - services required to maintain, program, install, repair, and support rapid deployment of radio subscriber units
- **O&M Services** - services required to operate and maintain tactical communications systems
- **Engineering** - services required to provide spectrum support, and to architect, design, and implement tactical communications systems
- **General** - ability to provide Project Management Services and a variety of other services in other service subcategories and Project Management Support (Radio, O&M Services, and Engineering)

NOT AN AUTHORIZED USER BUT INTERESTED IN TACCOM II?

If an agency is not listed above it is still possible to obtain written CO authorization to order against this IDIQ. To obtain authorization the Ordering Contract Officer (OCO) must contact the MAC CO and indicate their intent to order from TacCom II. The OCO must send an email to the MAC CO with subject line "Request for Authorization to Order from TacCom II". The email must include a statement of work, the period of performance, the estimated total order value, and the primary point of contact. Determine Technical Category

2. Ordering entities will determine the appropriate technical category based on estimated work predominance:
TC1 or TC2



Generate Bid Package

3. 1. Indicate set-aside info, if applicable.
2. Email the appropriate TacCom II mailbox for the selected TC.
3. Bid will go out to all IDIQ holders within the selected TC.



Receive & Evaluate Quotes

4. The OCO will receive and evaluate quotes according to the evaluation methodology and issue a task/delivery order to the successful contractor. The form contents and method of delivery depend on the order and policies of ordering agency.



Post-Award Notices And Debriefs

5. FAR 16.505 (b)(6)(i) will be followed for procedures for post-award notices and debriefs.
